NEW WORLD ANGELS PRIVACY POLICY

New World Angels (the “Company”) is committed to maintaining robust privacy protections for its users. Our Privacy Policy (“Privacy Policy”) is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Site.

For purposes of this Agreement, “Site” refers to the websites, owned and operated by Company, which can be accessed at www.newworldangels.com. The terms “we,” “us,” and “our” refer to the Company where applicable. “You” refers to you, as a visitor or user of our Site.

Please review the following terms carefully. By accessing and/or using the Site, whether paid or not, you hereby agree to each of the terms and conditions set forth herein, in addition to the Web Site Terms of Use (“Terms of Use”) which can be found at www.newworldangels.com/terms. Company reserves the right to modify its Privacy Policy or Terms of Use, at any time, without notice. It is your responsibility to check our Privacy Policy and Terms of Use periodically for changes. a. INFORMATION WE COLLECT

When you access our Site, please be advised that we collect “Non-Personal Information” and “Personal Information.” **Non-Personal Information** includes information that cannot be used to personally identify You, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. **Personal Information** may include your email address, full name, phone number, and any other identifying information which you may submit to us in connection with your use of our Site.

Information collected via Technology. In an effort to improve the quality of our Site and/or enhance the User experience, we track information provided to us by your browser when you access or use our Site. We track this information using cookies, or small text files which include an anonymous unique identifier. Cookies are sent to a user’s browser from our servers and are stored on the user’s computer hard drive. Sending a cookie to a user’s browser enables us to collect Non-Personal information about that user and keep a record of the user’s preferences when utilizing our Site, both on an individual and aggregate basis. The Company may use both persistent and session cookies; persistent cookies remain on your computer after you close your session and until you delete them, while session cookies expire when you close your browser.

Children’s Privacy. The Site is not directed to anyone under the age of 13. The Site does not knowingly collect or solicit information from anyone under the age of 13 or allow anyone under the age of 13 to sign up for the Service. In the event that we learn that we have gathered personal information from anyone under the age of 13 without the consent of a parent or guardian, we will delete that information as soon as possible. b. HOW WE USE AND SHARE INFORMATION

Personal Information. Except as otherwise stated in this Privacy Policy, we do not sell, trade, rent or otherwise share for marketing purposes your Personal Information with third parties. We may also share Personal Information with outside parties if we have a good-faith belief that access, use, preservation or disclosure of the information is reasonably necessary to include, without limitation, meeting any applicable legal process or enforceable governmental request, taking precautions against liability, enforcing agreement terms, investigating potential violations, addressing fraud, security or technical concerns, or protecting against harm to the rights, property, or safety of our users or the public as required or permitted by law.

Non-Personal Information. In general, we use Non-Personal Information to help us improve our Site and customize the user experience. We also aggregate Non-Personal Information in order to track trends and analyze use patterns on the Site. c. HOW WE PROTECT INFORMATION

When we send a promotional communication to a user, the user can opt out of further promotional communications by following the unsubscribe instructions provided in each promotional e-mail. In the event we undergo a business transaction such as a merger, acquisition by another company, or sale of all or a portion of our assets, your Personal Information may be among the assets transferred. You acknowledge and consent that such transfers may occur and are permitted by this Privacy Policy, and that any acquirer of our assets may continue to process your Personal Information as set forth in this Privacy Policy.

However, we are not responsible for the privacy practices employed by those websites or the information or content they contain. This Privacy Policy applies solely to information collected by us through the Site. Therefore, this Privacy Policy does not apply to your use of a third-party website accessed by selecting a link on our Site. To the extent that you access or use the Site through or on another website or application, then the privacy policy of that other website or application will apply to your access or use of that site or application. As such, we encourage our users to read the privacy statements of other websites before proceeding to use them.

f. MISCELLANEOUS

1. If any part of this Privacy Policy or Terms of Use is held or found to be invalid or unenforceable, that portion of the policy will be construed to be consistent with applicable law, while the remaining portions of the policy will remain in full force and effect.

2. Any failure on our part to enforce any provision of this Privacy Policy or Terms of Use will not be considered a waiver of our right to enforce such provision. The terms of this Privacy Policy or Terms of Use shall not be construed against the Company by virtue of its having drafted them. Our rights under the Privacy Policy and Terms of Use will survive any termination of access or use of the Site.

The provisions of this Privacy Policy and Terms of Use are for the benefit of you, the Company, and related affiliates, officers, directors, employees, agents, representatives, vendors, licensors, licensees, suppliers and any third-party information providers to the Site.
